These forms will be available commencing on July 18, 2011 and must be filed with the Elections Dept. no later than August 12, 2011 at 5:00 pm. If the incumbent fails to file, the deadline is extended to August 17, 2011 at 5:00 pm for candidates other than the incumbent.

**BE ADVISED THAT** if there are no nominees or an insufficient number of nominees for each elective office and a petition for election is not timely filed, an appointment to such elective office shall be made.

Candidates filing a Statement of Qualifications for publication must do so no later than August 12, 2011 at 5:00 PM, or if no incumbent files, no later than August 17, 2011 at 5:00 PM.

The polls will be open from 7:00 am to 8:00 pm on Election Day, Tuesday, November 8, 2011. The counting of the ballots will commence at 8:00 pm at the Elections Dept., 2850 Fairlane Ct., Bldg. C, in Placerville. The public is invited to observe.
